*All board includes forage comprised of coastal hay, timothy grass hay, alfalfa and orchard grass hay. Supplemental feed provided depending on board type and TBD with owner prior to arrival based on specific needs of said horse. Training board packages do not include feed unless requested by owner.

Any feed requested for training horses will be paid for by owner if not provided. In Stride Equestrian can provide pick up or ordering service for feed needed by horse in training. Use of on site feed used by this facility is also available at the expense of the owner. Feed provided by In Stride Equestrian is forage based Crypto Aero, ground flax, alfalfa/timothy pellets, mineral salt*

Training Board Payment:

Payment for training board for said horse is due upon the first of every month. In the event that said payment is late by 5 days, owner will be charged a \$25 late fee. In the event that said payment is late by 10 days, owner will be charged a \$50 late fee. Any payment default beyond 10 days will result in a daily late fee charge of \$50. If owner of said horse is default of payment for 60 days, ownership of said horse will be seen as forfeit by owner and become property of In Stride Equestrian.

Monthly cost of training and board for said horse required by the first of each month is:_____.

Expenses:

Owner is responsible for cost of transportation to and from In Stride Equestrian Center if said horse is taken off property for any reason. Owner will also be responsible for payment of any veterinary bills for said horse in the event of injury or illness while being boarded at said facility. Owner will also be responsible for regular farrier fees and maintenance, as well as deworming while horse is at said facility. It is the responsibility of said owner to take out insurance on said horse to protect the owner of any risk of loss of said horse. In Stride Equestrian charges a \$20 holding fee for farrier services. There is also a \$20 holding fee for regular veterinary services. In case of emergency veterinary services needed, an extra \$10/15 min will be applied to veterinary holding charge. Other optional services/expenses include: monthly sand clear \$25/mo, daily hoof picking \$5/day, weekly grooming \$100/mo, daily fly prevention garlic supplement \$10/mo, exercise riding \$45/session, training session \$60/session, private lesson \$65/lesson bathing \$50, deworming \$20

Risk of Loss:

Trainer (Michele Arana) shall not be liable for any injury, accident, disease, theft, loss of use or death of any horse while being boarded at said facility and under trainer's custody. Owner agrees to defend and uphold that trainer, Michele Arana, or said affiliates of business and property are not responsible for any risk, liability, actions, costs and or damage arising from care and training of said horse.

Health Requirements:

Prior to drop off of said horse, owner must provide In Stride Equestrian with an up to date record (within 12 months) of negative coggins, deworming and vaccinations of said horse. If horse has previous or pre existing injury, please state and make clear what pre existing condition may be as well as provide records from said horse's vet.

While said horse is boarded at In Stride Equestrian Center, horse will receive full care and or training by Michele Arana and staff of said facility. Trainer has made clear what will be provided for said horse in terms of care and training. Training methods have been discussed with said owner of horse and have been deemed appropriate for said horse and level of competence.

Said owner has agreed to keep said horse at In Stride Equestrian Center for _____ months starting on _____. If said horse is being boarded with no specific date, board and training will roll over to the next month. 30 days notice for terminating boarding/training service is required by horse owner and In Stride Equestrian via email or written letter.
